While AI will undoubtedly continue to advance and improve, the need for human discernment and verification in the legal field remains paramount. In this regard, the role of the attorney is not diminished, but rather, it evolves alongside these emerging technologies.

#### 2. Claude.ai

A lean team of brilliant and reputable minds have crafted a compelling alternative to ChatGPT built upon a custom large language model up-to-date as of early 2023. Claude offers key advantages over ChatGPT specifically with word counts and the direct upload of documents. Claude can process approximately 75,000 words compared to ChatGPT's 3,000 words which makes a world of difference when summarizing large depositions and caselaw. The best part – Claude.AI is currently free.

#### 3. Parallel Search—CaseText

This free tool allows an attorney to enter a key holding he or she hopes the court has previously articulated and find the next closest sentence. The search is not reliant on specific keywords and instead searches through context – the results can be truly

astonishing. CaseText has heavily embraced large language models and has a number of compelling products that rely on ChatGPT's technology combined with a "vector" database of statutes and caselaw. The tech finds the most relevant "chunks" of cases and uses ChatGPT to parse an answer. Given the current setup, we believe that CaseText's larger product offering will face similar shortfalls as general LLM's like ChatGPT. We look forward to the inevitable development of a base LLM specifically trained on our entire body of statutes and caselaw and thus contextually aware of each part in light of the whole.

#### PART 1 – AI OVERVIEW

# I. Introduction: How it works. Is it Ethical?

#### A. ChatGPT and its development

ChatGPT, developed by OpenAI, is an advanced artificial intelligence (AI) Large Langue Model (LLM) that utilizes deep learning techniques to generate human-like text responses. It is based on the Generative Pre-trained Transformer (GPT) architecture, which enables it to seemingly understand and generate contextual responses in a conversational manner.

But how do these seemingly magical programs work under the hood? The core technology is actually similar to what suggests words as you type on your iPhone's keyboard. LLMs like ChatGPT are essentially very complex, powerful versions of autocomplete algorithms. They predict the next word in a sequence by analyzing patterns in vast datasets of text from books, websites and more. The AI is "trained" by processing billions of words so it learns these patterns.

ChatGPT's training data includes nearly all of Wikipedia, thousands of novels, academic papers, news articles and online content. Its advanced neural network detects relationships between words to determine probabilities of what words will likely follow others.

So when you type a prompt, ChatGPT predicts the most likely next words just like iPhone autocomplete – except it generates entire sentences and paragraphs instead of one word at a time. The result is surprisingly human-like text, but with no human actually involved in writing it. At its core, all ChatGPT does is identify patterns in huge

volumes of text data to make statistically based guesses about what words should come next. As far as we know, it's not actually reading and comprehending.

Of course, ChatGPT has limitations compared to humans. Its knowledge stops in 2021 when the model completed training. And while errors are relatively rare, users must verify any factual claims or advice rather than assuming 100% accuracy. But despite its limitations, this technology is still immensely powerful for generating and analyzing text.

The development of ChatGPT is significant for the legal field as it opens up new possibilities for improving efficiency and productivity in various aspects of legal practice. By leveraging this AI technology, lawyers can explore innovative ways to streamline their work processes, enhance client communication, and improve the overall delivery of legal services.

#### B. Is it Ethical? Yes.

Artificial intelligence has sparked intense discussion in the legal community about whether tools like ChatGPT have a place in ethical legal practice. AI can be utilized safely and effectively if attorneys understand their obligations. At the end of the day attorneys are merchants of words. Discounting the technology at this early stage would be akin to early engineers criticizing the calculator or accountants touting the abacus over the spreadsheet.

A highly publicized case of attorney sanctions illustrates the potential pitfalls of AI. In 2021, a federal judge in New York sanctioned attorney Steven A. Schwartz \$5,000 for relying entirely on incorrect caselaw cited by ChatGPT in a brief without verifying it. Schwartz copied verbatim text

suggested by the AI chatbot to oppose a motion to dismiss without bothering to check whether the cases actually supported his position. Schwartz's case serves as a reminder that attorneys must confirm any AI-generated legal citations and analysis just as we would from a human assistant or associate.

This duty stems directly from ethics rules that predate AI. Texas Disciplinary Rule 3.03 prohibits lawyers from making false statements to a tribunal. Comments on the same rule note that advocates are responsible for pleadings and other documents prepared for litigation. Blind reliance on AI output without supervision breaches lawyers' ethical obligations. But that does not mean AI inherently compromises legal ethics. With proper oversight, AI can generate useful drafts and research material to enhance productivity. The key is realizing AI is not a substitute for the attorney's own analysis and judgment.

To utilize AI ethically, lawyers must rigorously check any substantive legal assertions made in AI-generated documents instead of assuming correctness. For statute and case citations, we must pull the original sources to confirm they apply as stated. And we should feel comfortable editing or deleting any inaccurate AI content that could mislead a court.

Responsible use of artificial intelligence is entirely consistent with our ethical obligations. In fact, failing to leverage AI's advantages could eventually fall below a reasonable standard of attorney competence as technology advances. But lawyers must always apply their own critical thinking instead of offloading analysis to algorithms. AI does not get lawyers off the hook ethically - it just helps us practice law better when used conscientiously.
